

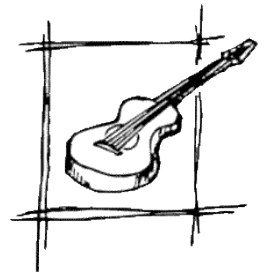

Merchandise

6). At Musician's option, Musician may offer CD's and other items for sale at the Performance. Musician will retain all proceeds from such sales. To facilitate Musician's merchandising, Purchaser will provide a table and chairs set up in an easily accessible and visible area of the venue.

Promotion

7). At Musician's request, please facilitate a marketing campaign that will include but not be limited to: Social Media platforms, on site advertising, venue's own website and associated web based advertising outlets.

Cancellation

8). In the event Purchaser cancels the Performance less than ____ week(s) prior to the scheduled date, Purchaser will pay Musician a sum equal to (select one) _____ Dollars (\$ ____) or ____% percent of the set fee specified in paragraph 5. Upon payment of the cancellation fee, Purchaser will have no further liability to Musician hereunder.

Taping Policy

9). Purchaser will not record, reproduce or transmit in or from the premises in any manner or by any means, the Performance without the written approval of Musician.

Miscellaneous

10). This Performance Agreement and the attached rider set forth the entire agreement between the parties, and may not be amended except in a writing signed by both parties. This Performance Agreement will be governed by and construed in accordance with the laws of the State of Michigan, without regard to the principles of conflicts of law. In any action or proceeding involving a dispute between the Purchaser and the Musician arising out of this Performance Agreement, the prevailing party will be entitled to receive from the losing party reasonable attorney's fees. Musician and Purchaser have each caused this Performance Agreement to be signed by its duly authorized representative.
