

Cancellation

8). Miscellaneous

10). This Performance Agreement and the attached rider set forth the entire agreement between the parties, and may not be amended except in a writing signed by both parties. This Performance Agreement will be governed by and construed in accordance with the laws of the State of Michigan, without regard to the principles of conflicts of law. In any action or proceeding involving a dispute between the Purchaser and the Musician arising out of this Performance Agreement, the prevailing party will be entitled to receive from the losing party reasonable attorney's fees. Musician and Purchaser have each caused this Performance Agreement to be signed by its duly authorized representative.
